#### Introduction

- Established data base of Geographical Indications (GIs) products and Traditional specialties established;
- Created guidelines and checklist to verify labelling of organic products in the market in accordance with EU regulations and provide procedures for the analysis of organic products to test the presence of prohibited Pesticides Products (PPs)
- Proposal for establishment of a national data base for operators (producers, processors, traders, etc.) and a register of organic seeds and seedling material.
